# Background

- Vietnam assessed one among 5 countries most seriously affected by CC. Adaptation is an important strategy.
- No separate national action plan for adaptation, but existing NAP addresses both **adaptation and mitigation.**
- Sectoral APs: Health, Construction, Agriculture, etc.





## CC Related-Policy in Vietnam

- National Target Program to Respond to CC (NTP-RCC) 2008-2012 dated 02 Dec 2008
- National CC Strategy dated 05 Dec 2011
- NTP-RCC 2013-2015 dated 30 Aug 2012
- NAPCC 2012-2020 date 5 Oct 2012
- Resolution No.24-NQ/TW - Proactively responding to CC, boosting resource-management and environmental protection dated 6 Mar 2013

# M&E for CC-related policies

**NTP-RCC:** carried out at national, sectoral and local levels

- **District level:**

- DiNRE: Information collection and preparing regular reports
- People's Committee (PC): periodically submits reports to standing agency of the NTP-RCC of provinces/centrally-governed cities

- **Province/City level:**

- DONRE: manage, archive relevant information & data; monitor and instruct DiNRE submit reports timely
- PC: synthesize and submit regular reports to Exe. Board

- **Central level:**

- Ministries, sectors: regularly report to Exe. Board
- Exe. Board: manage, archive information reported; monitor, instruct ministries, sectors and provinces/cities to submit reports timely, ..., develop & submit regular reports to Standing Office to submit to PM

# M&E for CC-related policies

## **NTP-RCC 2013-2015:**

- Implemented in accordance with the Regulation on management and implementation of national target program
- State management agencies: coordinate in monitoring and supervising the implementation.
- MONRE with ministries, central agencies promulgate plans on M&E of program implementation (incl. cross-sectoral monitoring and evaluation plan) and develop indicators and criteria for evaluating program implementation.

# **Drafted M&E criteria system of implementation of NTP-RCC 2012-2015**

## **Including 15 criteria:**

- CC and Sea level rise scenarios
- CC impact assessment
- Identify CC response solutions
- Sectoral action plan to respond to CC
- National action plan to respond to CC
- Develop maps for flooding, natural disasters and climate
- Develop digital elevation modeling map for delta and coastal areas

# **Drafted M&E criteria system of implementation of NTP-RCC 2012-2015**

- CC and SLR monitoring system
- Formulate CC adaptation policy in prior sectors/areas
- Formulate GHG mitigation policy in prior sectors/areas
- International Cooperation in CC
- Awareness on CC
- Education and Training on CC
- CC response models
- Mainstream CC into strategies, planning, policies and national programs.

# Drafted M&E criteria system for implementation of NTP-RCC 2012-2015

## Three completeness levels:

- Not started yet = 0%
- On going = 50% (some cases: up to % of completeness)
- Issued = 100%

**Reporting period:** Mostly “annually”



# Challenges

- Lack of methodology for CCA M&E
- Lack of supporting legal documents, instruments, tools of M&E
- Data missing
- Vague selected indicators/criteria
- Limitation of personnel capacity
- Financial issue for M&E
- Concern and seriousness of stakeholders in carrying out M&E
